Admin. Order No. AOSC21-17, as amended, and *In re: COVID-19 Administrative Orders*, Fla. Admin. Order No. AOSC23-25 (Apr. 27, 2023)).

The judges designated herein of the various JUDICIAL CIRCUITS OF FLORIDA, under and by virtue of the authority hereof, are hereby vested with all and singular powers and prerogatives conferred by the Constitution and laws of the State of Florida upon a judge of every other circuit and county of the State.
