The Clerk's Office will be open Saturday and Sunday, November 18 and 19, 2000, from 9:00 a.m. to 5:00 p.m. The Court's Public Information Office will be open during the same hours.

Initial briefs on the merits shall be filed by 2:00 p.m. Saturday, November 18, 2000; answer briefs on the merits shall be filed by 12:00 noon Sunday, November 19, 2000, and the reply brief on the merits shall be filed by 3:00 p.m. Sunday, November 19, 2000. Please file an original and seven copies of all briefs. Per this Court's Administrative Order In Re: Mandatory Submission of Briefs on Computer Diskette dated February 5, 1999, counsel are directed to include a copy of all briefs on a DOS formatted 3-1/2 inch diskette in Word Perfect 5.1 (or higher) format.
