the petition for extraordinary writ and alleges as follows:

1. According to press accounts, the Palm Beach County Canvassing  
Board has voted to suspend its recount for the purpose of awaiting a ruling from

the Circuit Court in Palm Beach County as to the issue of whether the Palm Beach County Canvassing Board is required to count unperforated “dimpled” ballots as votes. The subject hearing is scheduled for 9:00 a.m. in Palm Beach County. The Board’s actions further demonstrate the necessity that this Court act to protect the integrity of the process and ensure the application of a uniform rule of law.
