The Florida Board of Bar Examiners, through its Chair, the Honorable Scott L. Baena of Miami, Florida, has announced that the grades from the July 2019 General Bar Examination have been approved for release by the Supreme Court of Florida.

On July 30-31, 2019, 3,162 applicants took the Bar Examination in Tampa, Florida. The Supreme Court posted the pass/fail results for each applicant on its website and score reports were mailed to each applicant today.

The Court approved 1,487 candidates for admission to The Florida Bar on September 16, 2019, and Chief Justice Charles T. Canady has announced that they may be sworn in as members of The Florida Bar. Formal induction ceremonies to swear in the new attorneys will be held at the Supreme Court, and the Second, Third, Fourth, and Fifth District Courts of Appeal on Wednesday, October 2, 2019.
