FLORIDA BOARD OF BAR EXAMINERS ANNOUNCES RELEASE OF FEBRUARY 2022 GENERAL BAR EXAMINATION RESULTS

The Florida Board of Bar Examiners, through its Chair, the Honorable Jennifer Martinez Mooney of Tampa, Florida, has announced that the grades from the February 2022 General Bar Examination have been approved for release by the Supreme Court of Florida.

Calculations in the attached statistical summary reflect first-time applicants taking the Overall Method (or both Parts A & B) only. It is important to recognize the attached summary does not include all applicants taking the February 2022 examination, as explained below, and therefore is not valid to calculate an overall passing rate. The information on this page reflects the passing percentages for the applicants taking both parts of the examination and for those taking only one portion of the examination.

On February 22-23, 2022, 1,788 applicants took the Bar Examination in Tampa, Florida. Of these applicants, 1,348 took Part A and Part B (Overall Method) of the General Bar Examination, 209 took Part A (Florida portion) only, and 231 took Part B (MBE portion) only. Applicants repeating the examination are permitted to bank a passing status and thus may choose to retake only one portion of the examination. Applicants eligible to transfer in a passing MBE score from another jurisdiction may take only Part A of the examination.

Of the 1,348 applicants who took both Part A and Part B of the General Bar Examination in February 2022, 599 (44%) passed. Of the 209 applicants who took Part A only, 151 (72%) passed. Of the 231 applicants who took Part B only, 81 (35%) passed.

The Court approved 443 candidates for admission to The Florida Bar on April 11, 2022, and Chief Justice Charles T. Canady has announced that they may be sworn in as members of The Florida Bar. This group is not inclusive of all applicants who passed the examination as the character and fitness investigations for some applicants who passed the examination are ongoing. Completion of the character and fitness investigation and

successful completion of the Florida Bar Examination are both required before an applicant can be approved for admission.

Formal induction ceremonies to swear in the new attorneys will be held at the First, Second, Third, Fourth, and Fifth District Courts of Appeal on Monday, May 2, 2022.

FEBRUARY 2022 GENERAL BAR EXAMINATION OVERALL METHOD
